### **Mission Statement:**

The mission of the Affordable Housing Investors Council is to increase knowledge and awareness of the benefits of investing in affordable housing tax credit properties, to educate corporate investors on all aspects of affordable housing, and to discuss issues of importance to investors within the industry.

### **Criteria for Membership:**

Corporate membership in the Affordable Housing Investors Council is open to corporate tax credit investors. To be eligible, companies must do business in the United States and:

Make equity investments in affordable housing tax credit properties for their own accounts **or**

Have made investments in the past and now manage those investments.

A company whose primary long term involvement in the affordable housing tax credit market is as a seller, reseller, broker or consultant is not eligible for membership. Membership is annual and renewable under terms and conditions set forth by the Board of Governors and all new memberships are subject to Board approval.

### **Annual dues:**

Annual corporate dues are only \$1,250 year.
